2. The Merchant shall agree to accept real time payment for the service using mobile banking under Fonepay Network.
3. Merchant will be solely responsible for the transactions carried out using this service.
4. The Merchant shall have an account in SIFCO in order to receive the payment made for the service by the customer through mobile banking under Fonepay Network.
5. The merchant shall display the promotional materials and QR code provided by SIFCO in a noticeable area.
6. SIFCO is not liable for any dispute arising between the merchant and the mobile banking customer about the service delivery, quality of service and goods as the SIFCO's service transaction is based on real time.
7. SIFCO will charge the merchant with an appropriate fee as agreed by the merchant in this application which may change from time to time. The fee will be debited from the account of the merchant based on the debit authority signed by the merchant in this application form.
8. The Merchant warrants, represents and certifies that all information supplied by the Merchant and any other documentation submitted in support of this agreement including, among others, a copy of the Merchant business registration certificate, PAN certificate and other submitted documents, are complete, true and correct.
9. The Merchant shall ensure that the logo of SIFCO shall be displayed in parity with all other forms of payment supported by the Merchant on the Merchant's business outlet where various payment options are featured for the purchase of goods and/or services. The Merchant shall present a truthful description of QR Code payment services in accordance with SIFCO.
10. The Merchant shall be solely liable for the complaints, goods rejections, disputes arising out of the illegal, false and defects and poor quality of products.
11. Both parties can terminate this Agreement by giving thirty (30) days prior notice in writing.
12. This Agreement comes into effect once it is signed by the merchant and remains valid until it is terminated with the clause mentioned above in clause no 11.
13. If either of the party or business of the party is found or declared illegal under the laws of Nepal by the authority of the Nepal government or court in Nepal, the other party shall terminate this agreement with or without further notification to the party.
14. All disputes and differences relating to charges or claims arising out of QR Code transactions or as to the clarification of this 'Terms & Conditions' shall be amicably settled by both parties. If failed to settle amicably, the matter shall be exclusively in the jurisdiction of the court of Nepal.
15. The rights obtained under this 'Terms & Conditions' are not transferable without written approval from SIFCO.
16. SIFCO, at its own discretion, is entitled to add, alter, delete or modify any of the terms and conditions contained herein by prior written intimation to the merchant.
